Privacy Policy

This Privacy Policy describes our policies and procedures regarding the collection, use, and disclosure of your information when you use our app ("Service") and informs you about your privacy rights and how the law protects you.

We utilize your personal data to enhance and improve the Service. By using the Service, you consent to the collection and usage of information as per this Privacy Policy. This Privacy Policy has been generated with the assistance of a Privacy Policy Generator.

Interpretation and Definitions

Interpretation

The capitalized terms herein shall have the same meaning as defined under the following conditions. Irrespective of whether they appear in singular or plural, the following definitions shall apply.

Definitions

For the purposes of this Privacy Policy:

Account refers to a unique account created by you to access our Service or its parts.

Application refers to "Hestia: Voice-Controlled Recipes," the software program provided by our company.

Company (referred to as "the Company," "We," "Us," or "Our" in this Agreement) refers to Hestia: Voice-Controlled Recipes.

Country refers to Brazil.

Device means any device capable of accessing the Service, such as a computer, cellphone, or digital tablet.

Personal Data encompasses any information that relates to an identified or identifiable individual.

Service refers to the Application.

Service Provider denotes any natural or legal person who processes data on behalf of the Company. This term refers to third-party companies or individuals employed by the Company to facilitate the Service, provide the Service on behalf of the Company, perform services related to the Service, or assist the Company in analyzing how the Service is used.

Usage Data refers to data collected automatically, either generated by the use of the Service or from the Service infrastructure itself (for example, the duration of a page visit).

You refers to the individual accessing or using the Service, or the company, or other legal entity on behalf of which such individual is accessing or using the Service, as applicable.

Collection and Use of Your Personal Data

Types of Data Collected

Personal Data

While using our Service, we may request you to provide us with certain personally identifiable information that can be used to contact or identify you. This may include, but is not limited to:

Usage Data

Usage Data is collected automatically while using the Service.

Usage Data may comprise information such as your Device's Internet Protocol address (e.g., IP address), browser type, browser version, the pages of our Service that you visit, the time and date of your visit, the time spent on those pages, unique device identifiers, and other diagnostic data.

When accessing the Service via a mobile device, we may automatically collect specific information, including, but not limited to, the type of mobile device you use, your mobile device's unique ID, your mobile device's IP address, your mobile operating system, the type of mobile Internet browser you use, unique device identifiers, and other diagnostic data.

Information Collected while Using the Application

While using our Application, with your prior permission, we may collect:

Pictures and other information from your Device's camera and photo library

We utilize this information to provide features of our Service and to enhance and customize the Service. The information may be uploaded to our servers and/or a Service Provider's server or stored solely on your device.

You can enable or disable access to this information anytime through your Device settings.

Use of Your Personal Data

The Company may utilize Personal Data for the following purposes:

To provide and maintain our Service, including monitoring the usage of our Service.

To manage your Account: To manage your registration as a user of the Service. The Personal Data you provide can grant you access to different functionalities of the Service available to you as a registered user.

For the performance of a contract: The development, compliance, and undertaking of the purchase contract for the products, items, or services you have purchased or of any other contract with us through the Service.

For other purposes: We may use your information for other purposes, such as data analysis, identifying usage trends, determining the effectiveness of our promotional campaigns, and to evaluate and improve our Service, products, services, marketing, and your experience.

We may share your personal information in the following situations:

With Service Providers: We may share your personal information with Service Providers to monitor and analyze the use of our Service, to contact you. For business transfers: We may share or transfer your personal information in connection with, or during negotiations of, any merger, sale of Company assets, financing, or acquisition of all or a portion of our business to another company. With Affiliates: We may share your information with our affiliates, in which case we will require those affiliates to honor this Privacy Policy. Affiliates include our parent company and any other subsidiaries, joint venture partners, or other companies that we control or that are under common control with us.

With business partners: We may share your information with our business partners to offer you certain products, services, or promotions.

With other users: When you share personal information or otherwise interact in the public areas with other users, such information may be viewed by all users and may be publicly distributed outside.

With your consent: We may disclose your personal information for any other purpose with your consent.

Retention of Your Personal Data

The Company will retain your Personal Data only for as long as necessary for the purposes set out in this Privacy Policy. We will retain and use your Personal Data to the extent necessary to comply with our legal obligations (for example, if we are required to retain your data to comply with applicable laws), resolve disputes, and enforce our legal agreements and policies.

The Company will also retain Usage Data for internal analysis purposes. Usage Data is generally retained for a shorter period, except when this data is used to strengthen the security or to improve the functionality of our Service, or we are legally obligated to retain this data for longer time periods.

Transfer of Your Personal Data

Your information, including Personal Data, is processed at the Company's operating offices and in any other places where the parties involved in the processing are located. This means that this information may be transferred to — and maintained on

 computers located outside of your state, province, country, or other governmental jurisdiction where the data protection laws may differ than those from your jurisdiction.

Your consent to this Privacy Policy followed by your submission of such information represents your agreement to that transfer.

The Company will take all steps reasonably necessary to ensure that your data is treated securely and in accordance with this Privacy Policy, and no transfer of your Personal Data will take place to an organization or a country unless there are adequate controls in place, including the security of your data and other personal information.

Delete Your Personal Data

You have the right to delete or request that we assist in deleting the Personal Data that we have collected about you.

Our Service may give you the ability to delete certain information about you from within the Service.

You may update, amend, or delete your information at any time by signing in to your Account, if you have one, and visiting the account settings section that allows you to manage your personal information. You may also contact us to request access to, correct, or delete any personal information that you have provided to us.

Please note, however, that we may need to retain certain information when we have a legal obligation or lawful basis to do so.

Disclosure of Your Personal Data

Business Transactions

If the Company is involved in a merger, acquisition, or asset sale, your Personal Data may be transferred. We will provide notice before your Personal Data is transferred and becomes subject to a different Privacy Policy.

Law enforcement

Under certain circumstances, the Company may be required to disclose your Personal Data if required to do so by law or in response to valid requests by public authorities (e.g., a court or a government agency).

Other legal requirements

The Company may disclose your Personal Data in the good faith belief that such action is necessary to:

Comply with a legal obligation
Protect and defend the rights or property of the Company
Prevent or investigate possible wrongdoing in connection with the Service
Protect the personal safety of Users of the Service or the public
Protect against legal liability

Security of Your Personal Data

Children's Privacy
